**ZonePerfect Chocolate Carmel Cluster Bars
Champions Chocolate Peanut Butter Bars
Glucerna Chocolate Peanut Bars**

Dear Customer:

Abbott Nutrition is voluntarily recalling its ZonePerfect Chocolate Carmel Cluster bars, Champions Chocolate Peanut Butter bars by EAS and Glucerna Chocolate Peanut bars. This recall affects only the products that are listed above.

No other Abbott Nutrition products are affected by this recall.

Abbott Nutrition is recalling these products because peanut granules in the products were sourced from Peanut Corporation of America's (PCA) Plainview, Texas facility.

Abbott Nutrition previously recalled ZonePerfect Chocolate Peanut Butter bars, ZonePerfect Peanut Toffee bars and NutriPals Peanut Butter Chocolate bars because they contained peanut butter from PCA's Blakely, GA facility.

All peanut ingredients that Abbott Nutrition utilizes in its other products come from suppliers other than PCA and are not affected by this recall.

Please immediately check your inventory for these products (UPC list attached):

In addition, if you have distributed this product, you are required to notify your customers of this URGENT PRODUCT RECALL. Please direct them to check their inventory for these products, place the affected products on hold and work with your customers in returning the product to you. If your customers destroy the product, you must capture the necessary above-mentioned destruct information.

Your prompt attention to this important matter is essential to a successful resolution of this recall including either shipment of replacement product or receipt of credit for returned or destroyed product.
